REGISTRATION FEE: This fee is non-refundable.

RE-ENROLLMENT FEES: \$35 per child / per school site
There is a two week minimum waiting period for students who withdraw from Marion Afterschool Programs. To re-enroll in the program during the current school year a new contract must be submitted and parent must pay the \$35.00 re-enrollment fee.

SIBLING DISCOUNT: A sibling discount will be applied to full paying families with three or more students enrolled at the same Marion Afterschool Programs site. A discount of 10% will be applied to the third child and each additional child.

- PAYMENT PROCEDURE:** Marion Afterschool Programs will accept online payments only.
- All payments are due in advance. **Payment is due on Friday for the following week. Please refer to the payment schedule provided below. All dates are subject to change based on school calendar changes.**
 - Per District Policy, Marion Afterschool Programs cannot extend credit. A **\$15** late fee will automatically be applied to your account on Monday if your account balance is not paid in full by **11:59PM Sunday**. Account balances must be paid in full in order for a student to be permitted to attend Marion Afterschool Programs.
 - All fees are designated as "**FLAT RATE FEES**" meaning a single-fixed fee charged weekly for service *regardless of usage*.
 - Example... If your child is out ill for a week, you are still required to pay the flat rate fee to hold his/her spot.
 - Example... If there are only two school days in a week, you are still required to pay the full weekly rate.
 - Example... If your child only attends 2 days in a week, you are still required to pay the full weekly rate.

HURRICANE POLICY: The flat rate fee policy will apply to weeks with unexpected closures due to hurricanes. Marion Afterschool Programs *may* only consider giving credits when school is unexpectedly closed for five days (Monday-Friday) within the same week.

LATE PICK-UP FEE: A late pick-up fee of \$10 is charged for each 15 minutes after 6:00PM, measured by the School Clock.
* 6:01-6:15 = \$10.00 per child * 6:16-6:30 = \$20.00 per child * 6:31-6:45 = \$30.00 per child * 6:46 = Abandoned Child Procedure Initiated.
Children who remain on site after 6:46PM will be released into the custody of a law enforcement officer. We reserve the right to dismiss your child from the program after three late pick-ups. DELINQUENT ACCOUNTS: Students with delinquent accounts will not be registered in Marion Afterschool Programs until the balance is paid in full, including emergency drop-ins.
